Results	Total Monthly Income of Applicants
Criteria met	At least 2.75 times monthly rent
Criteria met with increased security deposit	At least 2.25 times but less than 2.75 times monthly rent
Criteria not met	Less than 2.25 times monthly rent

### **Credit History**

No Credit File/Score Criteria met with increased security deposit.

Result	Score
Criteria met	675 or higher
Criteria met with increased security deposit	625-674
Criteria not met	624 or lower

#### Bankruptcies

Result	Bankruptcies
Criteria not met	Any open bankruptcies
Criteria met with increased security deposit	Any discharged bankruptcies within the last 7

#### Accounts in Collection
