## SHEFFIELD GREENE CONDOMINIUM ASSOCIATION VISITORS' GUIDE

This is a quick reference guide for owners and visitors new to our community. Everyone is welcome at Sheffield Greene, and we hope the following information will be helpful to you. Owners who are leasing should refer to the Association policy requiring them to complete the appropriate application form and to pay the \$50.00 administration fee. This applies to <u>all</u> types of rentals.

- Trash and Recycling Materials. Trash and recycling materials are picked up on Monday mornings. Receptacles may be placed at the end of your driveway one hour before sunset on Sunday. Empty containers must be removed before sunset on Monday.
- Parking. Parking is permitted only in your garage or driveway. Use visitor
  parking for overnight guests when necessary. Cars may park on the street
  for short periods during the day. No commercial vehicles are permitted for
  any reason, other than contractors providing a service in the community.
- Pool Rules. Please read and obey the pool rules. Please note: no running, diving, jumping or excessive noise in the pool area. We hope you enjoy the pool but ask that you be considerate of the unit owners surrounding the pool area.
- Walkways. Whenever possible, please use the walkways to access the pool area as it is very difficult to maintain a nice grassed area in this climate.
- Outdoor Grilles. In accordance with the Sarasota County Fire Code, no gas grilles or open flame grilles are permitted. Electric grilles may be used.
- <u>Problems</u>. Residents who are leasing should contact the owner or the rental agent regarding problems with their condominium unit.
- Pets. All pets must be less than 15 inches in height and be on a leash when they are on the common areas. Owners must remove all pet droppings.

If you have any questions, such as where the water shut off valve is located, please do not hesitate to ask one of your neighbors who will be more than willing to assist you.
